- Sealed tenders are invited from the publishers/whole sellers/dealers/distributors/agents book sellers for the Indian Printed Textbooks related to Veterinary Sciences / Animal Sciences / Fishery Sciences/ Animal Biotechnology/ Wildlife Science for University Library, NDVSU, Jabalpur (M.P.)
- 2. The price of the tender document is Rs.1000 (Rupees one thousand only) in the form of demand draft in favour of NDPCVV, Dean Faculty, Jabalpur which is non-refundable and has to be submitted along with the tender document.
- 3. The tender document can be downloaded from university website www.ndvsu.org
- 4. The last date for submission of duly filled tender document to the Dean Faculty, Nanaji Deshmukh Veterinary Science University, Adhartal, Jabalpur (M.P).-482004 only through speed/registered post is **26/02/2020** at **5.00 pm**
- 5. The technical bids are to be opened at the first instance on 28/02/2020 at 03:00 pm and evaluated by competent committee or Authority. The financial bids of the technically qualified firms will be opened 02/03/2020 at 3:00 pm.
- 6. The anticipated value of tender document is Rs. 5.403 lakhs (Five lakhs forty thousands and three hundred only) for printed textbook. The amount can be increased or decreased.
- 7. The supply of the Printed textbooks are to be F.O.R delivery at University Library, South Civil Lines, NDVSU, Jabalpur (M.P.)
- 8. The Vendor must be registered for the type of business.
- 9. The Vendor must not be blacklisted by any National/State level institutions.
- 10. The vendor must be member of The Federation of Publishers' & Booksellers' Associations in India/Good Office Committee (GOC) for 2019-2020.
- 11. The authorization letter from the publisher in reference to the present tender, should be attached otherwise the tender will be rejected.
- 12. The vendor shall provide a list of agencies (Government/Statutory bodies/Professional, educational institutions/State /Central Agricultural Universities) along with annual sales turnover for the last three years.
- 13. The vendor should be specialized in supply of textbooks related to Veterinary Sciences / Animal Sciences / Fishery Sciences/ Animal Biotechnology/ Wildlife Science.

- 14. The annual turnover of the Vendor for the last three financial years must be at least Rs. 50.00 Lakhs (Fifty Lakhs) per annum. Submission of Name and address of bankers with satisfactory banker's report regarding tenderers/vendors financial capability for doing business worth Rs. 50.00 Lakhs (Fifty Lakhs) in last three years should be attached.
- 15. The rates should be quoted in Indian Rupees only both in figure and words along with discount rate.
- 16. All pages of the tender should be duly signed by authorized signatory of the applicant firm.
- 17. The vendors/suppliers short listed are required to strictly agree to supply as per the Nanaji Deshmukh Veterinary Science University, Jabalpur Terms and Conditions.

- 22. Only paperback editions are to be supplied. Hardbound editions are not to be supplied. In case where paperback editions are not available hardbound editions may be supplied (Certificate of non availability of paperback edition from publisher must be attached).
- 23. Tender should be in sealed envelopes and marked with "Tender for Supply of printed textbooks related to Veterinary Sciences / Animal Sciences / Fishery Sciences/ Animal Biotechnology/ Wildlife Science". Sealed outer envelope must contain separately two sealed envelopes marked as 'A' technical bid and marked as 'B' commercial/financial bid. Envelope 'A' must contain a demand draft of Rs 1000 (Rupees one thousand) and a Security Deposit of Rs. 20000/- (Twenty thousand) in the form of Fixed Deposit Receipt (FDR), is to be enclosed.
