

1. Tenders are invited in sealed covers addressed to the Undersigned by Registered post and with "Acknowledge Due" or delivered personally, so as to **reach on or before 31-03-2020 upto 12.00 PM**. The cover shall bear the address of Tenderer and shall be super-scribed the words.

**TENDER FOR**

(A) LIVESTOCK AND POULTRY FEED INGREDIENTS” (wef 01-04-2020 to 31-03-2021)

(B) LIVESTOCK AND POULTRY READYMADE FEED (wef 01-04-2020 to 31-03-2021)

(C) DRY FODDER (**WHEAT, GRAM AND MASOOR BHUSA**) wef .01-04-2020 to 30-06-2020)

2. The tender form may be obtained from the undersigned in cash or crossed by depositing the I.P.O./DD worth Rs. 500/- payable to the Dean, College of Veterinary Science and Animal Husbandry, Mhow on working hours up to **30-03-2020 up to 4.00 PM**
3. The tender shall not be acceptable without the receipt of earnest money/ security deposit in the shape of fixed deposit receipt of 2%) of the cost of each item, (i.e.Rs.10, 000/- for feed ingredients and Rs.10,000/- for readymade feed) issued on any Nationalized Bank duly discharged in the name of "Dean, College of Veterinary Science & Animal Husbandry, Mhow, which will be refunded after warranty period.
4. The above amount of earnest money/ security shall be refunded in full if the tender is rejected.
5. Security would be taken for due performance of the contract as per provisions of the conditions mentioned in the Tender Forms, and will be refunded within twelve months of the expiry of the contract or successful completion of the supply, with reference to specifications with proper supply and adjustment of any less by way of purchasing the goods from other party/parties in case of dishonouring of the indent and deliberate non supply, etc. due to which any part of the central security deposit will be forfeited in full.
6. No person of Firms is permitted to submit more than one tender of each category under different names.
7. The rates tendered shall not be altered by the tenderer during the terms of the contract.
8. The submission of a tender by a tendered implies that he has read the terms and conditions of tender/ contract and has made himself aware of the scope and specifications of the supplies to be made. He also must satisfy himself regarding suitability and availability of the goods.
9. The rates quoted should be F.O.R. delivery at College of Vety.Sci. & A.H., Mhow. The rates quoted should be inclusive of packing and forwarding charges loading/unloading in feed godowns of college dairy/handling charges, freight, full risk coverage, insurance, etc.

10. a) **The Envelope-A** containing Cash Receipt of Rs 500/- towards the cost of tender form, Income Tax, GST clearance certificate, Authorization/Manufacture certificate and other relevant documents. b) **The Envelope-B** containing price of commodity quoted by tenders. c) **The Envelope-C** containing Fixed Deposit Receipt (FDR) as earnest money/ security deposit. d) **Envelope-D** containing all the three envelopes (**envelope A, B and C**). (e) **Envelope -E** containing feed samples of tendered commodity and this envelope will separately attached with **envelope D** failing which the tender shall not be accepted.
- 11 The tenders will be opened by a committee, so appointed for the purpose in the presence of tenderer or their authorized representative at **3.00 PM on 31-03-2020**. In case any tenderer fails to present him at the scheduled time, the competent authority shall have the right to open any tender in the absence of concerned tenderer or his representative.
- 12 The undersigned does not bind to accept only the lowest rates.
13. All dues regarding taxes including GST, sale tax, on the supply will be payable by the contractor himself.
- 14 In case feed ingredients are not accepted or not supplied during the time limit prescribed or not made good made good according to the terms and conditions laid down above, the tenderer shall be liable to pay, per pay, a penalty of 2% of the cost or order placed which shall be deducted from the bills to be paid to his or from the amount of security deposit. In case, however, no supply is made after the expiry of prescribed period, the undersigned reserves the right to purchase from open market or next tenderer, in which extra cost shall be deducted from the amount of security deposit or the pending bills and the contract shall stand terminate the remaining amount of security deposited will be forfeited to College of Veterinary Science and Animal Husbandry, Mhow.
- 15 The rates will remain valid up to 31-03-2021
- 16 The material supplied by the tenderer will be liable to the demonstration at college of Veterinary Science and Animal Husbandry, Mhow by the supplier free of cost.
- 17 If tenderer failed to execute any part of the contract mentioned above, the security deposit will be liable to be forfeited by the competent authority.
